

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Projecting Cost for the Completion and Predesign for
the Schuk Toak District)

RESOLUTION NO. 95-089

WHEREAS, the Secretary of Interior bears the responsibility for completion of designs and construction of facilities for the Schuk Toak New Farm project as contemplated under the Southern Arizona Water Rights Settlement Act of 1982 (SAWRSA); and

WHEREAS, the Tohono O'Odham Nation did enter into a P. L. 93-638 Cooperative Agreement with the Bureau of Reclamation to complete predesign and design for the Schuk Toak New Farm Project; and

WHEREAS, completion of designs is scheduled for Fiscal Year 1996 and construction activities must be initiated to coordinate with design completion; and

WHEREAS, the Nation's Water Projects Office has developed estimates for direct and indirect costs associated with administering construction efforts under a proposed P. L. 93-638 agreement, totalling approximately \$23.3 million over the next four (4) fiscal years.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that the Secretary of Interior be made aware of the

estimated cost projections so that funding may be timely and
properly appropriated and allocated by the Federal Government.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 6TH day of MARCH, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by Section 1(j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
