BE IT FURTHER RESOLVED that the Appropriations Committee shall submit a report to the Tohono O'odham Legislative Council upon their return.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 06TH, day of March, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 08 ABSENT, pursuant to the powers vested in the Council by Section 1(j) and Article XVI Section 9 of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
