**(Approving the Legislative Branch FY95 Budget Amendment No. 1)**

**RESOLUTION NO. 95-092**

**WHEREAS, the Legislative Branch FY95 budget was approved by the Legislative Council on September 22, 1994 by Resolution No. 94-408; and**

**WHEREAS, amendments affecting the funding level or change in the purpose for which the funds were budgeted are required to be submitted for review and approval by the Legislative Council; and**

**WHEREAS, the proposed amendment was approved on March 2, 1995 by the Budget & Finance Committee to increase the Legislative Branch FY95 budget by \$104,429.00 to allow for purchases of vehicles and a copier; and**

**WHEREAS, the Legislative Branch FY95 budget does not have a capital equipment line item.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves Amendment No. 1 to approve the addition and establishment of Capital Equipment Line Item-320 in the amount of \$104,429.00.**

**BE IT FURTHER RESOLVED that the sources of funding will be the General Revenue Account.**




