

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 95 Employment Assistance Budget Modification #1)**

RESOLUTION NO. 95-103

WHEREAS, the Tohono O'Odham Nation is presently operating the Employment Assistance Program under FY 1995 P. L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, any amendments affecting the funding or funding levels of the grant shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment has been submitted to reflect the reduction to the Indirect Cost from 30.7% to 15.5% and include new line of Mileage - GSA to the FY - 1995; and

WHEREAS, the Employment Assistance Program has prepared and submitted its budget modification for review and approval by the Tohono O'Odham Legislative Council.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the amendment to the Employment Assistance Program and requests the Bureau of Indian Affairs to incorporate the said budget into the Employment Assistance Program.

24 ABSENT, pursuant to the powers vested in the Council by Section I(f) of Article
25 VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
26 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
27 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
28 Section 16 of the Act of June 18, 1934 (48 Stat. 984).


