RESOLUTION NO. 95-105

**WHEREAS, the Tohono O'odham Department of Human Services, Division of
Child Welfare Service, Family Preservation Program is presently
operating under the Title II Indian Child Welfare Act (ICWA) of
1978; and**

**WHEREAS, any amendments affecting the funding or funding levels of the
grant shall be submitted for review and approval by the Tohono
O'Odham Legislative Council; and**

**WHEREAS, an amendment has been submitted to reflect the reduction of the
Indirect Cost from 30.7% to 15.5% for review and approval by the
Family Preservation Program.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
Council does hereby approve the amendment to the Family
Preservation Program and authorizes expenditures in accordance
with the attached budget.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the
Tohono O'Odham Nation's Officials, to wit: the Chairman and any**



designated official are hereby authorized to negotiate and execute
the grant provided however, that any amendments affecting the
funding or funding levels of the grant shall be submitted for
further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council
on the 9TH. day of MARCH, 1995 at a meeting at which a quorum was present
with a vote of 1,511.0 FOR; -0- AGAINST; -0- NOT VOTING; and 252.0 [10]
ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article
VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).


