**RESOLUTION NO. 95-123**

**WHEREAS, O'Odham Construction & Materials has been authorized to continue**  
**operation since December 1994 under Legislative Resolution 94-513**  
**for a period not to exceed 90 days; and**

**WHEREAS, this authorization to continue operations for O'Odham Construction**  
**& Materials expires March 13, 1995; and**

**WHEREAS, the required detailed financial analysis as required by Resolution**  
**94-513 has been completed but not yet reviewed by the Legislative**  
**Council or the appropriate Legislative Committees; and**

**WHEREAS, the Executive Office has requested authorization to continue**  
**operations for 30 days or until the Legislative Council and members**  
**of the Budget & Finance and the Appropriations Committees were**  
**present to address the detailed financial analysis report.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**  
**Council authorizes O'Odham Construction & Materials to continue**  
**operations for 30 days pending a review of company's detailed**  
**financial and management analysis.**
