8 to address some of the dialysis patient's needs; and,

11 travel expense for the Dialysis Council members; and,

13 **WHEREAS,** The Dialysis Council budget Resolution 95-006 is modified from
14 within its budget to cover the new line item travel expense in the
15 amount of \$2,500; and

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative
19 Council has reviewed and approved the second budget modification
20 of the Dialysis Council from within its original budget to include
21 line item travel expense in the amount of \$2,500.
