**WHEREAS, the Tohono O'odham Nation is presently operating the Early
Childhood Head Start Program funded by the Department of Health
and Human Services, Family Support Administration (DHHS/FSA);**

and

**WHEREAS, the Nation has been informed of its Program Improvement and Cost
of Living Adjustment Funds for FY1995 Early Childhood Head Start
Program in the amount of \$39,188.00; and**

**WHEREAS, any amendments affecting the funding or funding levels of the
grant shall be submitted for review and approval by the Tohono
O'odham Legislative Council; and**

**WHEREAS, an amendment has been submitted for review and approval by the
Early Childhood Head Start Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
Council that it does hereby approve the amendment to the Early
Childhood Head Start Program and authorizes expenditures in
accordance with the attached budget.**

further prior approval by this Council.

Article XVI Section 9 of the Constitution of the Tohono O'Odham Nation, adopted
by the Tohono O'Odham Nation on January 18, 1986; and approved by the
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
