O'odham children; and**

**WHEREAS, the Tohono O'odham Legislative Council is desirous of continuing  
this program for the benefit of its young members.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council  
that it does hereby approve the proposed contract for FY 1996 Title  
XX - Child Day Care Services.**

**BE IT FURTHER RESOLVED that the duration of the contract will be from  
July 01, 1995 through June 30, 1996.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the  
Tohono O'odham Nation's officials, to wit: the Chairman and any**

the contract, provided however, that any amendments affecting the  
funding or funding levels of this contract shall be submitted for  
further prior approval by this Council.

on the 13TH day of March, 1995 at a meeting at which a quorum was present  
with a vote of 1,511.0 FOR; -0- AGAINST; -0- NOT VOTING; and [252.0]  
11 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(3) and  
Article XVI Section 9 of the Constitution of the Tohono O'Odham Nation, adopted  
by the Tohono O'Odham Nation on January 18, 1986; and approved by the  
Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,  
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


