

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Removing Councilman Chester L. Antone from Office)**

LEGISLATIVE ORDER NO. 95-136

WHEREAS, the Legislative Council held a hearing on March 28, 1995 to hear the accusation for removal against Councilman Chester L. Antone on charges of gross neglect of duty brought by Council Chairperson Alex J. Ramon; and

WHEREAS, the Accused entered a plea of "no contest" which the Council interpreted as a refusal to plead; and

WHEREAS, after due consideration by the Council the Presiding Officer entered a guilty verdict against Councilman Chester L. Antone, in accordance with Rule 17 of the Special Rules of Procedure Upon Accusation for Removal adopted by the Legislative Council by Legislative Order No. 95-101; and

WHEREAS, in conformity with the same Rule 17 referred to above, the Council members voted on the question of whether to remove Councilman Chester L. Antone from office; and

WHEREAS, the Legislative Council, by majority vote, voted to remove Councilmember Chester L. Antone from office.

3 **NOW, THEREFORE, BE IT ORDERED THAT:**

5 (1) A guilty verdict is hereby entered against Councilman Chester
6 L. Antone for the removable offense of gross neglect of duty.

8 (2) Councilman Chester L. Antone is hereby removed from
9 office as Legislative Council Representative of Pisinemo
10 District.

12 (3) A copy of this Legislative Order shall be provided to the
13 Accused and the Accuser within five (5) business days following
14 the date of this decision.

17 The foregoing Order was passed by the Tohono O'Odham Council on the 28TH,
18 day of MARCH, 1995 at a meeting at which a quorum was present with a vote
19 of 1,262.0 FOR; 501.0 AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to
20 the powers vested in the Council by Section 1 of Article XIII of the Constitution
21 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by
22 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
23 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984); and
24 Section 2 of Article IX of the Uniform Election Ordinance of the Tohono
25 O'Odham Nation adopted November 18, 1986.
