RESOLUTION NO. 95-146 (Amending the Attorney Contract with the Law Firm of Rothstein. 1 Donatelli, Hughes, Dahlstrom, Cron & Schoenburg) Page 2 of 5 2 3 arising out of the operation of the Desert Diamond Casino; and 4 5 WHEREAS. the operating budget for the Office of Attorney General does not 6 contain any additional allocation of funds to supplement the 7 8 attorney contract with the Rothstein Firm, so that there is a need 9 10 to identify an alternate source of funding for the attorney contract 11 with the Rothstein Firm; and 12 13 WHEREAS. by Resolution No. 94-452, the Legislative Council determined that 14 the services and representation provided by the Rothstein Firm 15 16 protects the Nation's interests in the operation of the Desert 17 Diamond Casino and directed that the amount appropriated for 18 19 payment of the fees and expenses under the attorney contract be 20 21 paid from the budget of the Desert Diamond Casino; and 22 it is in the interest of the Nation to continue that payment WHEREAS, 23 24 arrangement for the duration of the term of the attorney contract 25 with the Rothstein Firm; and 26 27 the Domestic Affairs Committee and the Commerce Committee WHEREAS. **28** recommend that the Legislative Council approve Amendment No. 1.
