4 **WHEREAS,** at a meeting of the Pisinemo District Council held on March 15,

6 1995, discussion was held pertaining to the issue of the Pisinemo

8 District employees who are presently not covered under any type

10 of insurance; and

11 **WHEREAS,** further discussion concluded that the employees of the Pisinemo

13 District should be covered by insurance for the sake of the

15 employees and their families; and

16 **WHEREAS,** upon further discussing this issue, a majority of the members of the

18 Pisinemo District Council, voted in favor of getting full insurance

20 coverage for the employees of the Pisinemo District; and

21 **WHEREAS,** the Pisinemo District currently has monies available to cover the

23 cost of full insurance coverage (\$9,725.00) to include Blue Cross/Blue

25 Shield, Dental, Life and Disability for a term of five (5) months
beginning May 01, 1995 and ending September 30, 1995.

26 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'Odham Legislative



VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).


