**RESOLUTION NO. 95-158**

**WHEREAS, Low Income Home Energy Assistance funds have been made available to the Tohono O'Odham Nation for FY 1996 through the State of Arizona, Department of Economic Security; and**

**WHEREAS, the Tohono O'Odham Nation does meet the eligibility requirement to operate a Low Income Home Energy Assistance Program; and**

**WHEREAS, it is in the best interest of the Tohono O'Odham Nation to apply for FY 1996 Low Income Home Energy Assistance funds to assist needy families with their residential utility bills; and**

**WHEREAS, the Tohono O'Odham Nation does desire to secure funding for provision of services during Fiscal Year 1996.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby approve the proposal to the State of Arizona, Department of Economic Security for FY 1996 Low Income Home Energy Assistance funding.**

**BE IT FURTHER RESOLVED that the duration of the contract is July 01, 1995 through June 30, 1996.**



**BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 6TH day of APRIL, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 09 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
