

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Housing Standards and Building Codes including Standards for Home Renovation using Federal Monies supplied to Indian Nations by the Department of Housing and Urban Development's HOME and Indian CDBG Programs)

RESOLUTION NO. 95-168

WHEREAS, Department of Housing and Urban Development guidelines require adoption of housing quality and construction standards on projects funded through the Department's HOME and ICDBG programs; and

WHEREAS, the Tohono O'Odham is applying for funds from both programs to be used in renovating housing within the O'Odham Nation; and

WHEREAS, the Nation recognizes the need and desirability for such standards and building codes to ensure quality housing for all members of the Nation.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that all projects funded in the 1995 cycle of the HUD HOME and ICDBG programs renovation work on all homes will conform to the Uniform Building Code as amended and applied in Pima County, Arizona, the Cost-Effective Energy Conservation and Effectiveness Standards (CEECS) detailed in 24 CFR Part 39, and Housing Quality Standards (HQS) detailed in 24 CFR 882.109.
