

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**(Agreement to Comply with HUD's Terms and Conditions for  
Indian HOME Grant Assistance)**

**RESOLUTION NO. 95-169**

**WHEREAS, the Tohono O'Odham Nation is applying for HOME grant Assistance funds from the Department of Housing and Urban Development (HUD) to provide both substantial and moderate renovation of homes for low income families; and**

**WHEREAS, the Tohono O'Odham Legislative Council elected to adopt a resolution to apply for the HUD Indian HOME grant; and**

**WHEREAS, a condition of application is to provide maximum leverage funds by the Nation equalling 100% of the \$1,500,000 requested in the Tohono O'Odham Nation's grant proposal; and**

**WHEREAS, nothing in this resolution is intended to waive, nor should any terms herein, or in the HOME grant proposal, be read or implied to waive the Tohono O'Odham Nation's sovereign immunity.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that the Nation agrees to appropriate \$1,500,000 of matching funds to the HUD Grant if the 1995 HOME Grant is awarded.**

Nation agrees to comply with all terms and conditions expressed in HUD's Notice of Home Grant Funds Availability published in the Federal Register January 17, 1995 with applicable provisions of 24 CFR part 92 Home Investment Partnership Program and provisions of any grant agreement entered into with HUD or any other stipulations made by HUD and agreed to in writing by a duly authorized representative of the Tohono O'Odham Nation pertaining to the grant assistance provided by HUD.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 07TH day of April, 1995 at a meeting at which a quorum was present with a vote of 1,533.0 FOR; -0- AGAINST; -0- NOT VOTING; and 230.0 (10) ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
