

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY96 Elderly Title III Proposal July 1, 1995 - June 30, 1996)**

RESOLUTION NO. 95-172

WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly members of the Nation; and

WHEREAS, funding for the operation of the Elderly Program has been possible in part by Title III of the Older American's Act of 1965 as amended, through the Administration of the Inter-Tribal Council of Arizona; and

WHEREAS, the services provided to elderly members has been beneficial and services continue to be necessary to provide nutritional and social support; and

WHEREAS, the Elderly Program has prepared for FY 1995 Title III funding to provide nutritional and social support services to eligible elderly members.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the proposal for Title III funding for the Elderly Program to continue to provide such services it has proposed in light of the requirements and regulations.

BE IT FURTHER RESOLVED, that the duration of this grant shall be from July 01, 1995 through June 30, 1996.

BE IT FINALLY RESOLVED, by the Tohono O'odham Legislative Council that the Tohono O'odham Nation Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of this grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH, day of April, 1995 at a meeting at which a quorum was present with a vote of 1,533.0 FOR; -0- AGAINST; -0- NOT VOTING; and [230.0] 10 ABSENT, pursuant to the powers vested in the Council by Section I(d) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
