4 **WHEREAS,** the Tohono O'odham Nation through the Planning & Operations  
5 Department did advise the communities and districts of the Nation  
6 of the availability of funds for Home renovation projects to be  
7 submitted to HUD for the 1995 Home Grant Program, and;

10 **WHEREAS,** the following communities and districts did apply and identify  
11 projects Baboquivari, Chukut Kuk, Hickiwan, Pisinemo, Schuk Toak,  
12 Gu Achi, San Lucy, Gu' Vo, Sif Oidak, San Xavier, and;

14 **WHEREAS,** the Nation is requesting 1.5 million dollars from HUD for home  
15 renovation.

17 **THEREFORE BE IT RESOLVED** that the Tohono O'odham Legislative Council  
18 hereby authorizes the Planning & Operations Department to submit  
19 an application to HUD for 1995 Home Grant Program.

22 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council  
23 in the 07TH, day of April, 1995 at a meeting at which a quorum was present with  
24 a vote of 1,533.0 FOR; -0- AGAINST; -0- NOT VOTING; and [230.0] 10  
25 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article  
26 VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
27 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
28 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to  
Section 16 of the Act of June 18, 1934 (48 Stat. 984).
