WHEREAS, the Tohono O'odham Nation is entitled to JTPA funds to develop a network of employment and training programs throughout the Nation; and

WHEREAS, the JTPA Program submits the following documents for review and approval for the Title IIB Contract Proposal for Fiscal year 1996:

- 1) Fiscal Year 1996 Administrative Cost Pool Budget in the amount of \$14,601.00 and**
- 2) Fiscal Year 1996 Program Budget in the amount of \$124,110.00 for a grand total amount of \$138,711.00**




