**RESOLUTION NO. 95-187**

**WHEREAS, the Legislative Council of the Tohono O'odham Nation is authorized**  
**by the Tohono O'odham Constitution Article VI, Powers of the**  
**Tohono O'odham Council, Section 1.d.3, Paragraph 3 of d asserts:**  
**to adopt, approve and amend annual budgets and to authorize the**  
**expenditure of funds in accordance with these budgets; and**

**WHEREAS, the Budget & Finance Committee recommends that the Nation's**  
**officials and employees would benefit from a 4% Cost of Living**  
**Adjustment to keep pace with inflation and employment practices**  
**in the general area of the Nation.**

**NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono**  
**O'odham Nation hereby approves a 4% Cost of Living Adjustment**  
**for the Nation's officials and employees effective October 01, 1995**  
**for the Nation's Fiscal Year 1996.**

**BE IT FURTHER RESOLVED that the Executive Branch of the Nation be advised**  
**that all budgets prepared and submitted to this Legislative Council**  
**for FY 1996 appropriations should include this 4% Cost of Living**



Adjustment and from the effective date of this resolution all proposals submitted to the Nation for funds from federal, state, local, and/or private entities should likewise include a request for funding consistent with this Cost of Living Adjustment.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 12TH, day of April, 1995 at a meeting at which a quorum was present with a vote of 1282.0 FOR; 98.0 AGAINST; 258.5 NOT VOTING; and 124[06] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




