**(Approving Tohono O'Odham Nation FY 1995 Modification to
Agricultural Extension Contract No. 1450CTH54T61049)**

RESOLUTION NO. 95-195

WHEREAS, the Tohono O'Odham Legislative Council approved Resolution No. 94-357 entitled "Agriculture Extension Program Receipt of \$30,000.00 from the Department of the Interior for Southern Boundary Fencing Materials and Labor Cost - Budget Modification";
and

WHEREAS, the \$30,000 was carried over from the FY 1994 budget to the FY 1995 in order to continue further preparations for implementation of this project; and

WHEREAS, the new budget totals \$33,953.00, which includes the indirect cost.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the FY 1995 Modification to the Agricultural Extension Contract No. 1450CTH54T61049 in the amount of \$33,953.00.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 1ST, day of May, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






