4 **WHEREAS,** the Tohono O'odham Gaming Authority proposes that traffic signals

6 be installed at the corner of Los Reales Road and Old Nogales

8 Highway near the Desert Diamond Casino to improve traffic safety
9
10 and convenience in and around the Casino property; and

11 **WHEREAS,** the Gaming Authority has presented a proposed Intergovernmental

13 Agreement with the State of Arizona and the City of Tucson for the
14
15 design, construction and maintenance of traffic signals and related
16
17 road improvements (the "IGA"), a copy of which is attached hereto

19 and incorporated herein by reference; and

20 **WHEREAS,** pursuant to the IGA, the Nation would be required to provide the

22 design plans and specifications for the bidding and construction and

24 to reimburse the City of Tucson all costs associated with the project
25
26 in excess of \$95,000; and

27 **WHEREAS,** the Gaming Authority is prepared to undertake all obligations and

duties of the Nation under the IGA and indemnify, defend and hold
the Nation harmless for any and all liability arising out of the

Nation's entering into the IGA; and

**WHEREAS, it is in the Nation's interest to promote and protect the safety and
welfare of its members, employees and patrons.**

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Legislative Council approves the Intergovernmental Agreement in the form attached hereto.**
- 2. The Gaming Authority shall assume all responsibility for the rights, duties and obligations of the Nation under the IGA, and the Gaming Authority shall indemnify, defend and hold harmless the Nation for any and all liability arising out of the Nation's entering into the IGA.**
- 3. The Nation's Chairman is authorized and directed to execute the IGA, provided that the Gaming Authority Board has approved and executed an agreement for the assumption of obligations and duties and indemnification of the Nation consistent with the requirements of this Resolution.**

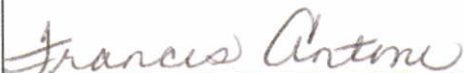
