

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 95 Credit and Finance - Budget Modification No. 1)**

RESOLUTION NO. 95-201

WHEREAS, the Tohono O'Odham Nation is presently operating the Credit and Finance Program under FY 1995 P.L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the Credit and Finance Program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby approve the amendment to the Credit and Finance Program contract and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman and any designated Official are hereby authorized to negotiate and execute the contract, provided however, that any amendment affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.


