LEGISLATIVE ORDER NO. 95-203

**WHEREAS, the Policies and Procedures of the Tohono O'Odham Council in
Article I, Section I.A., LEGISLATIVE CALENDAR, Subsection 1 & 3
states:**

**1. Prior to an official adjournment, the Legislative Council shall
adopt a Legislative Calendar which shall commence on the first
working day of June on which the Legislative Council will be
called into Legislative Session. The Calendar shall specify dates
for the general sessions, recess periods, recognized holidays, and
the days of adjournment.**

**3. The Legislative Calendar shall be based only on working days and
scheduled paid holidays; and**

**WHEREAS, the Rules Committee has prepared a Legislative Calendar in
accordance with the Policies and Procedures of the Tohono
O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
Council does hereby adopt the Legislative Calendar which
commences on June 5, 1995 and ends on May 31, 1996.**



11 **of the Act of June 18, 1934 (48 Stat. 984).**
