4 **WHEREAS,** pursuant to Resolution 94-473 the Tohono O'Odham Legislative

6 Council approved an attorney contract with the law firm of Brown

8 & Bain for fiscal year 1995 in the amount of \$45,000., for the

12 Farming Authority in certain bankruptcy proceedings initiated by

(the "Attorney Contract"); and

15 **WHEREAS,** additional funding is required to secure continued representation

17 through the remainder of this fiscal year; and

18 **WHEREAS,** the Budget & Finance Committee has approved Modification No. 2

20 to the budget of the Office of Attorney General which transfers

22 \$31,400., from certain line items to professional services; and

23 **WHEREAS,** the Domestic Affairs Committee recommends approval of the

25 attached Amendment No. 1 to the Attorney Contract to increase the
