RESOLUTION NO. 95-209

WHEREAS, Governor Fife Symington, did on April 17, 1995, appoint Willard Anita as a member of the Governor's Council on Developmental Disabilities; and

WHEREAS, Willard Anita is eminently qualified to serve the Indian Nations and people of Arizona and the State of Arizona; and

WHEREAS, the Legislative Council supports the recommendation for appointment of Willard Anita to assist in providing health services for the Indian people of the State of Arizona.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby support and confirm the appointment of Willard Anita to the Governor's Council on Developmental Disabilities.


The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 4TH, day of May, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
