

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 94-519)**

RESOLUTION NO. 95-210

WHEREAS, in 1989, the Legislature of the State of Arizona created by legislation an Advisory Council on Indian Health Care by provision of HB 1348, the AHCCCS Omnibus Bill; and

WHEREAS, by Resolution No. 94-519, the Legislative Council supported and confirmed the appointment of Willard Anita, Chairman of the Health & Human Services Committee to the State Advisory Council on Indian Health Care; and

WHEREAS, the Legislative Council by same resolution appointed Legislative Chairman, Alex J. Ramon as alternate representative to the State Advisory Council on Indian Health Care; and

WHEREAS, by letter dated April 26, 1995, Governor Fife Symington, did notify Legislative Chairman Ramon on his appointment of Willard Anita to the Arizona Advisory Council on Indian Health Care; and

WHEREAS, it is necessary to amend Resolution No. 94-519 to withdraw Alex J. Ramon as alternate representative.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby amend Resolution No. 94-519 to

withdraw Alex J. Ramon, as alternate representative to the
Governor of Arizona's Advisory Council on Indian Health Care.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 4TH, day of May, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


