contract with the Indian Health Services; and**

**WHEREAS, any amendments affecting the funding or funding levels of the  
contract shall be submitted for review and approval by the Tohono  
O'odham Legislative Council; and**

**WHEREAS, the Tohono O'odham Nation did submit its final financial report for  
FY 1993 and identified carry-over funds in the amount of  
\$54,932.00; and**

**WHEREAS, an amendment has been submitted for review and approval by the  
Psychological Services Program.**

**NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council  
that it does hereby approve the amendment to the Psychological  
Services Program contract and authorizes expenditures in  
accordance with the attached budget.**



hereby requests and authorizes the IHS to de-obligate FY 93 Carry-over funds from the FY 93 Contract No. 249-93-0004 and re-obligate these funds in the FY 95 Contract No. 249-95-0004.

**BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 4TH, day of May, 1995 at a meeting at which a quorum was present with a vote of 1,763.0 FOR; -0- AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
