RESOLUTION NO. 95-217

WHEREAS, Resolution No. 93-364 suspended the Farm Management Board pending investigation of issues brought forth by O'Odham members or employees of the Farm Authority; and

WHEREAS, Resolution No. 93-364 appointed the Legislative Agriculture Committee as the Interim Farm Board to oversee the operations at the same time to conduct the investigation; and

WHEREAS, the Interim Farm Board has completed its assigned obligation with a recommendation that Directors be nominated in accordance with the Tohono O'Odham Farming Authority Restated Plan of Operation; and

WHEREAS, the Chairman has appointed Eugene P. Tashquinth, Sr., from the Sif Oidak District, as a member of the Management Board of the Farming Authority pursuant to the Restated Plan of Operation; and

WHEREAS, Eugene P. Tashquinth, Sr. has the qualifications to be a member of the Farm Board.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that Eugene P. Tashquinth, Sr. is approved as a Director of the Farm Management Board to serve the remaining term of the suspended Board, ending August 31, 1995.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 5TH day of MAY, 1995 at a meeting at which a quorum was present with a vote of 1,571.0 FOR; -0- AGAINST; 68.0 NOT VOTING; and 124.0 [08] ABSENT, pursuant to the powers vested in the Council by Section 1(b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




