RESOLUTION NO. 95-222

WHEREAS, Resolution No. 93-364 suspended the Farm Management Board pending investigation of issues brought forth by O'Odham members or employees of the Farm Authority; and

WHEREAS, Resolution No. 93-364 appointed the Legislative Agriculture Committee as the Interim Farm Board to oversee the operations at the same time to conduct the investigation; and

WHEREAS, the Interim Farm Board has completed its assigned obligation with a recommendation that Directors be nominated in accordance with the Tohono O'Odham Farming Authority Restated Plan of Operation; and

WHEREAS, the Chairman has appointed Mary Jane Lewis from the San Lucy District, as a member of the Management Board of the Farming Authority pursuant to the Restated Plan of Operation; and

WHEREAS, Mary Jane Lewis has the qualifications to be a member of the Farm Board.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that Mary Jane Lewis is approved as a Director of the Farm


