RESOLUTION NO. 95-227

WHEREAS, the Tohono O'odham Nation in 1986 requested funds from Congress to finance the development of a health system designed for the unique needs of the Tohono O'odham Nation; and

WHEREAS, the Nation's proposed project to design a health system became known as the Demonstration Project; and

WHEREAS, the Demonstration Project has been in existence from Fiscal Year 1988 to the present fiscal year 1995; and

WHEREAS, the requirements of the Demonstration Project includes the provision of an evaluation report to the Congress of the United States; and

WHEREAS, the Indian Health Service and the Tohono O'odham Nation agreed to a Fourth Generation Methodology; and

WHEREAS, the Clary Institute of La Jolla, California entered into a contract with the Tohono O'odham Nation to perform the evaluation of the Demonstration Project.


