**RESOLUTION NO. 95-229**

**WHEREAS, the Tohono O'odham Nation, through its Planning and Operations Department did advise the Communities and Districts of the Tohono O'odham Nation of the availability of funds and types of eligible projects for the Department of Housing and Urban Development's Indian Community Development Block Grant Program (ICDBG); and**

**WHEREAS, the following Communities and Districts did request ICDBG funding for FY 1994, but were not submitted to HUD, due to the Grant ceiling limitation;**

17 Section 16 of the Act of June 18, 1934 (48 Stat. 984).




