**WHEREAS, the Tohono O'Odham Nation has successfully operated a program**  
**for the elderly members of the Nation; and**

**WHEREAS, the Department of Human Services/Senior Services Division has**  
**submitted for review and approval an agreement between the**  
**National Indian Council on Aging and the Tohono O'Odham Nation**  
**to provide Senior Community Services Employment Program.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
**Council that it does hereby approve the Host Agency Agreement**  
**between the National Indian Council on Aging and the Tohono**  
**O'Odham Nation.**

**BE IT FURTHER RESOLVED that the term of this Agreement shall commence on**  
**July 01, 1995 and end on June 30, 1996.**

**BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the**  
**Tohono O'Odham Nation's Officials, to wit: the Chairman and any**  
**designated official are hereby authorized to negotiate and execute**  
**the Agreement, provided however, that any amendments affecting**

the funding or funding levels of the Agreement shall be submitted  
for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 8TH day of MAY, 1995 at a meeting at which a quorum was present with a vote of 1,627.0 FOR; -0- AGAINST; -0- NOT VOTING; and 136.0 [09] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




