RESOLUTION NO. 95-243

WHEREAS, the Tohono O'Odham Nation is presently operating the Management of Health Services under FY 1995 P.L. 93-638 contract with the Public Health, Indian Health Services; and

WHEREAS, the Tohono O'Odham Nation does desire to renew for provision of services during FY 1996; and

WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approves the FY 1996 Office of the Executive Director Renewal proposal and budget.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does authorize and request the Public Health, Indian Health Service to renew with the Tohono O'Odham Nation under P. L. 93-638, as amended, for provision of services titled: Office of the Executive Director

BE IT FURTHER RESOLVED that the duration of this renewal shall commence on October 01, 1995 through September 30, 1996.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in






