**WHEREAS, the Tohono O'Odham Nation is presently operating the Community
Health Services/Community Counseling and Relation Services
component under FY 1995 P.L. 93-638 contract with the Public
Health, Indian Health Services; and**

**WHEREAS, the Tohono O'Odham Nation does desire to renew for provision of
services during FY 1996; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
approved the Community Health Services/Community Counseling
and Relations Services Component FY 1996 proposal and budgets.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
Council does authorize and request the Public Health, Indian Health
Service to renew with the Tohono O'Odham Nation under P. L. 93-
638, as amended, for provision of services titled: Community Health
Services/Community Counseling and Relations Services**

**BE IT FURTHER RESOLVED that the duration of this renewal shall commence
on October 01, 1995 through September 30, 1996.**

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the

Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract has been awarded by the Indian Health Service, unless the agency authorizes and approves pre-award costs consistent with the Indian Self-Determination Act, as amended.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the

Tohono O'Odham Nation's Officials, to wit: the Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 18TH day of MAY, 1995 at a meeting at which a quorum was present with a vote of 1,504.0 FOR; -0- AGAINST; -0- NOT VOTING; and 259.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono


