**RESOLUTION NO. 95-248**

**WHEREAS, the Tohono O'Odham Nation is presently operating the Social Service Program under FY 1995 P.L. 93-638 contract with the Bureau of Indian Affairs; and**

**WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'Odham Nation and its people; and**

**WHEREAS, the Tohono O'Odham Nation does desire to renew for provision of services during FY 1996; and**

**WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the FY 1996 Family Assistance/Child Welfare renewal proposal and budgets.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does authorize and request the Bureau of Indian Affairs to renew with the Tohono O'Odham Nation under P. L. 93-638, as amended, for provision of services titled: FY 1996 Family Assistance/Child Welfare Program.**

**BE IT FURTHER RESOLVED that the duration of this renewal shall commence on October 01, 1995 through September 30, 1996.**

3 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the

5 **Tohono O'Odham Nation will not fund or operate the program in**  
6 **the interim while negotiations are still being conducted and no**  
7 **executed contract has been approved by the Bureau of Indian**  
8 **Affairs, unless the agency authorizes and approves pre-award costs**  
9 **consistent with the Indian Self-Determination Act, as amended.**

12 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that the  
13  
14 **Tohono O'Odham Nation's Officials, to wit: the Chairman and any**  
15 **designated official are hereby authorized to negotiate and execute**  
16 **the contract, provided however, that any amendments affecting the**  
17 **funding or funding levels of this contract shall be submitted for**  
18 **further prior approval by this Council.**

22 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council**  
23 **on the 18TH. day of MAY, 1995 at a meeting at which a quorum was present**  
24 **with a vote of 1,504.0 FOR; -0- AGAINST; -0- NOT VOTING; and 259.0 [10]**  
25 **ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
28 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
