

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1996 Adult Care Group Home Renewal Proposal)**

RESOLUTION NO. 95-254

WHEREAS, the Tohono O'odham Nation is presently operating the Adult Care Group Home under FY 1995 P.L. 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham Nation and its people; and

WHEREAS, the Tohono O'odham Nation does desire to renew for provision of services during FY 1996; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed and approved the FY 1996 Adult Care Group Home renewal proposal and budget.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does authorize and request the Bureau of Indian Affairs to renew with the Tohono O'odham Nation under P.L. 93-638 as amended for the provision of services titled: Adult Group Home Program.

BE IT FURTHER RESOLVED that the duration of this renewal shall commence on October 01, 1995 through September 30, 1996.

14 **designated official are hereby authorized to negotiate and execute**
15 **the contract provided however, that any amendments affecting the**
16 **funding or funding levels of the contract shall be submitted for**
17 **further prior approval by this Council.**
