

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY96 Johnson O'Malley Program Renewal Proposal)**

RESOLUTION NO. 95-257

WHEREAS, the Tohono O'odham Nation is presently operating the Johnson O'Malley Program under FY 1995 93-638 contract with the Bureau of Indian Affairs; and

WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham Nation and its people; and

WHEREAS, the Tohono O'odham Nation does desire to renew for provision of services during FY 1996; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed and approved the FY 1996 Johnson O'Malley Program renewal proposal and budget.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council does authorize and request the Bureau of Indian Affairs to renew with the Tohono O'odham Nation under P.L. 93-638 as amended for the provision of serviees titled: Johnson O'Malley.

BE IT FURTHER RESOLVED that the duration of the renewal shall commence on October 01, 1995 through September 30, 1996.

7 **Affairs, unless the Agency authorizes and approves pre-award costs**
8 **consistent with the Indian Self-Determination Act, as amended.**

11 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the

13 **Tohono O'odham Nation's Officials, to wit: the Chairman and any**
14 **designated official are hereby authorized to negotiate and execute**
15 **the contract, provided however, that any amendments affecting the**
16 **funding or funding levels of the contract shall be submitted for**
17 **further prior approval by this Council.**

25 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**
28 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


