**WHEREAS, the Tohono O'odham Nation has operated successfully an Early  
Childhood, Headstart and Day Care Program for its young members;**

**and**

**WHEREAS, the Department of Economic Security, through a Child Adult Care  
Food Services Financial Agreement, provides reimbursement of funds  
for food costs incurred based on the guidelines identified in the  
agreement; and**

**WHEREAS, the Early Childhood, Headstart, Day Care Program submits for  
review and approval the Child Adult Care Food Program Budget for  
Fiscal Year 1996.**

**THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council  
that it hereby approves and authorizes expenditure in accordance  
with the attached budget; and**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the  
duration of the agreement shall commence on October 01, 1995  
through September 30, 1996.**



Tohono O'odham Nation's Officials, to wit: the Chairman and any designated Officials, are hereby authorized to negotiate and execute the agreement, provided however, that any amendments affecting the funding or funding levels of the agreement shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 18TH day of May, 1995 at a meeting at which a quorum was present with a vote of 1,349.0 FOR; -0- AGAINST; -0- NOT VOTING; and [414.0] 09 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
