

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1995 WIC Program Budget Modification #1)**

RESOLUTION NO. 95-274

WHEREAS, the Tohono O'odham Nation has provided preventive health care for women, infants and children; and

WHEREAS, the services provided to eligible clients has been beneficial and services continue to be necessary to help alleviate nutritional health risks and improve the health of individuals at risk; and

WHEREAS, any amendments affecting the funding level of the Memorandum of Agreement with the Inter-Tribal Council of Arizona shall be submitted fore review and approval by the Tohono O'odham Legislative Council; and

WHEREAS, an amendment has been submitted for review and approval by the Division of Community Health Representatives; Women, Infants and Children (WIC) Program.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the amendment and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, and any

designated official are hereby authorized to negotiate and execute the Memorandum of Agreement, provided however, that any amendments affecting the funding or funding levels of the memorandum of Agreement shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council the 19TH, day of May, 1995 at a meeting at which a quorum was present with a vote of 1,459.0 FOR; -0- AGAINST; -0- NOT VOTING; and [304.0] 09 ABSENT, pursuant to the powers vested in the Council by Section 1(d)3 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
