3 **WHEREAS,** the Tohono O'Odham Nation did on Saturday, May 27, 1995 conduct

5 a general election for the offices of Chairman and Vice Chairman
6
7 of the Tohono O'Odham Nation, as well as Representatives and

9 Alternates to the Tohono O'Odham Legislative Council; and

10 **WHEREAS,** the Election Board did issue and post its Certification of Election
11
12 Results in accordance with Section 6(E) of Article VII of the
13
14 Uniform Election Ordinance, certifying to the election of the
15
16 candidates who received the highest number of votes for elective
17
18 office; and

19 **WHEREAS,** under Section 6(N) of Article VII of the Uniform Election Ordinance,

21 it is incumbent upon this Council to issue Certificates of Election to
22
23 the candidates who received the highest number of votes for each
24
25 Council seat within twenty days after the Election Board has posted
26
27 its Certificates of Election results, provided however, that no
28
election contest statement has been filed against the candidates
within the time allowed and provided for, and provided further
that they hold no other elective office of the Nation; and

3 **WHEREAS,** pursuant to Section 1(B) of Article VII of the Uniform Election

5 **Ordinance,** the Certificate of District Residents was presented which

10 **2 of Article IV of the Constitution of the Tohono O'Odham Nation.**

11 **NOW, THEREFORE, BE IT RESOLVED** that the Chairman and Secretary of

15 **directed on behalf of the Council** to execute and deliver a

17 **Certificate of Election** to the following persons elected either at

23 **Alternates to the Tohono O'Odham Legislative Council, who shall**
24 **hold their offices for a term of four (4) years and until their**
