3 **WHEREAS,** the Tohono O'Odham Utility Authority proposes to construct a new  
4 water line extension to furnish water facilities and other related  
5 utility services for Homesites in the San Xavier Community/District,  
6 and has submitted a plat or map (Project 89-460) thereof to the  
7 San Xavier District Council showing the location and scope of the  
8 easement and delineating the utility facilities to be placed thereon;  
9 and the length of the line in the San Xavier Community is 473.00'  
10 x 40.00' wide, as set forth on the attached drawings; and

16 **WHEREAS,** the San Xavier District Council has met and determined that the  
17 routing and location of the easement for the water line extension  
18 and other utility services is not in conflict with the San Xavier  
19 District Land Use Plan adopted by the San Xavier District Council

21 the new water line extension will be of substantial benefit to the  
22 San Xavier Community, District, Tohono O'Odham Nation, and their

**WHEREAS, the San Xavier District Council has approved the easement for the location and construction of the new water line extension and has further recommended approval thereof by the Tohono O'Odham Legislative Council.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the easement for the location and construction by the TOUA of a new water line extension and other utility services to serve homesites in the San Xavier District (Project 89-460).**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 9TH day of JUNE, 1995 at a meeting at which a quorum was present with a vote of 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 [03] ABSENT, pursuant to the powers vested in the Council by Section 1(i) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
