5 **O'odham Senior Services Program with tribal funds; and**

7 **WHEREAS,** amendments affecting the funding level or change in the purpose  
8  
9 **for which the funds were budgeted are required to be submitted**  
10 **for review and approval by the Tohono O'odham Legislative**  
11 **Council; and**

13 **WHEREAS,** an amendment has been submitted for review and approval.

14 **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative  
15  
16 **Council that it hereby approves this amendment to transfer funds**  
17  
18 **in between line items and authorize expenditures in accordance**  
19 **with the attached budget modification.**

21 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council**  
22 **on the 9TH day of JUNE, 1995 at a meeting at which a quorum was present**  
23 **with a vote of 1,771.0 FOR; -0- AGAINST; -0- NOT VOTING; and 105.0 (3)**  
24 **ABSENT, pursuant to the powers vested in the Council by Section 1d(3) of Article**  
25 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
28 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
