**WHEREAS, the Tohono O'Odham Legislative Council is charged with the
responsibility of supporting endeavors which promote the education
and welfare of members of the Tohono O'Odham Nation; and**

**WHEREAS, the existing GED/Remedial Program under JTPA/JOBS Programs
currently operates without the use of computers, which in this day
and age, computerization has become a basic need in any entity to
support the learning process; and**

**WHEREAS, software and hardware for GED/Remedial Programs specifically have
become more readily available for purchase.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative
Council fully supports the Title II-A/Title II-C Budget Modification
to purchase capital equipment of seven (7) computers.**

**The foregoing Resolution was passed by the Tohono O'Odham Legislative Council
on the 13TH day of JULY, 1995 at a meeting at which a quorum was present
with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT,
pursuant to the powers vested in the Council by Section 1(f) of Article VI of the
Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984).**
