RESOLUTION NO. 95-353

WHEREAS, the Tohono O'Odham Nation is presently operating the Community Health Representative/Community Health Services Divisions under an FY 1995 P. L. 93-638 contract with the Department of Human Services/Indian Health Services; and

WHEREAS, the Nation was notified of additional non-recurring funding in the amount of \$156,477., for the Community Health Representative/Community Health Services Divisions to purchase Hand Held Computers and Software; and

WHEREAS, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and

WHEREAS, a budget has been submitted for review and approval by the Community Health Representatives/Community Health Services.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the budget to purchase Hand

Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH day of JULY, 1995 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
