

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Accepting \$100,000 in Federal Funding for Gila River Adjudication Program,  
and Authorizing Related Modification to P.L. 93-638 Contract and Amendment  
to Subcontract)**

**RESOLUTION NO. 95-371**

**WHEREAS, by Resolution 91-364, the Tohono O'odham Legislative Council  
authorized the execution of a P.L. 93-638 Contract (the "Contract")  
to conduct the Gila River Adjudication Program (formerly known  
as the Chui Chu Water Inventory Study) and further authorized the  
execution of a subcontract (the "Subcontract") with Natural  
Resources Consulting Engineers ("NRCE") to carry out the Program;  
and**

**WHEREAS, the Contract has since been entered into (Contract No.  
CTH54T61016) and, pursuant to authorization of the Legislative  
Council in Resolutions 92-273 and 93-072, has been modified to  
reflect the award of additional funding and an expansion in the  
scope of work; and**

**WHEREAS, the Subcontract and authorized amendments thereto have been  
entered into with NRCE; and**

**WHEREAS, in September 1994, the Nation was informed that the Bureau of**

**Indian Affairs ("BIA") had identified \$150,000 for a supplemental award under the Contract; and**

**WHEREAS, by Resolution 94-338, the Legislative council accepted this award and authorized an amendment to the Contract and Amendment No. 3 to the Subcontract to reflect such award; and**

**WHEREAS, the BIA's notice of additional \$150,000 in funds was subsequently determined to have been inaccurate; and**

**WHEREAS, in June 1995 the Nation received notice from the BIA that it has identified an additional \$100,000 in federal funding for the Contract (copy of notice attached); and**

**WHEREAS, the Water Resources Committee recommends acceptance by the Legislative Council of the additional funding award for the Contract and the negotiation of a modification to incorporate such funding for expenditure under the Contract through March 31, 1997, and further recommends approval of Amendment No. 4 to the NRCE Contract to reflect the correct amount of the supplemental award.**

**NOW, THEREFORE, BE IT RESOLVED that:**

- 1. The Tohono O'odham Legislative Council hereby accepts \$100,000 in supplemental funding for the P.L. 93-638 Contract on the Gila River Adjudication Program.**
- 2. The Chairman of the Nation is authorized to negotiate and execute (a) a Contract modification which incorporates the supplemental funding for expenditure through March 31, 1997, and (b) Amendment No. 4 to the NRCE Subcontract, in the form attached hereto, which incorporates the correct amount of supplemental funding.**
- 3. The Chairman of the Nation is further authorized to execute such other modifications to the Contract and Subcontract as may be appropriate, provided that any such modifications shall not change the amount of funding or the scope of work without prior approval of the Legislative Council.**
