4 **WHEREAS,** by Resolution 95-326, the Legislative Council approved an Attorney  
5  
6 Contract with Russell C. Winston for fiscal year 1995 in the amount  
7  
8 of \$1,500.; and

9 **WHEREAS,** the Attorney Contract was approved for the purpose of providing  
10  
11 legal representation to protect the Nation's interests under the  
12  
13 Indian Child Welfare Act in connection with an adoption proceeding  
14  
15 involving a child of an enrolled member of the Nation pending in  
16  
17 Shelby County Tennessee Chancery Court; and

18 **WHEREAS,** an additional \$1,000., is required for legal fees and expenses to  
19  
20 assure uninterrupted representation through September 30, 1995;

22 and

23 **WHEREAS,** funds in this amount are available for expenditure for this purpose  
24  
25 in the operating budget of the Office of Attorney General for fiscal  
26  
27 year 1995; and

28 **WHEREAS,** the Domestic Affairs Committee recommends approval of an

amendment to the Attorney Contract to increase the contract  
amount by \$1,000.

**NOW, THEREFORE, BE IT RESOLVED THAT:**

1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the Attorney Contract with Russell C. Winston, in the form attached hereto, which increases the Contract amount by the sum of \$1,000., payable from the fiscal year 1995 operating budget of the Office of Attorney General.
2. The Chairman of the Nation is authorized and directed to execute Amendment No. 1 to such Contract.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 9TH. day of AUGUST, 1995 at a meeting at which a quorum was present with a vote of 1,876.0 FOR; -0- AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
