4 **WHEREAS, on August 10, 1995, the Legislative Council did discuss storm**
5
6 **damages to homes of members of the Nation within the boundaries**
7
8 **of the Tohono O'Odham Nation; and**

9 **WHEREAS, the storm damages to homes of Nation members occurring on**
10 **August 3rd, and August 7th, 1995 were extensive and are**
11
12 **considered a danger to the safety and welfare of those families**
13
14 **affected by these storm damages; and**

15 **WHEREAS, the Executive Office did receive requests for emergency assistance**
16
17 **from families whose homes were damaged from the storm and**
18
19 **obtained estimated costs for materials and labor for required**
20 **repairs; and**

21 **WHEREAS, the Legislative Council previously had appropriated funds for such**
22
23 **emergencies for Fiscal Year 1995 within the Executive Budget for**

25 **such emergencies; and**

26 **WHEREAS, the Executive Office, to date, has expended approximately 98.9%**

13 **BE IT FURTHER RESOLVED** that the sum of \$18,202.87 for the purchase of

15 materials and costs for labor to repair the storm damaged homes

17 shall be taken from the Nations General Revenue Account.



25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
