**WHEREAS, the FY 1995 Legislative Branch Budget will end at midnight
September 30, 1995 and all spending authority granted under the
FY 1995 Budget will end at that time; and**

**WHEREAS, the FY 1995 Budget (Resolution No. 94-408) was amended by
Resolution No. 95-092 to increase the FY 1995 Budget to
\$1,079,374.00; and**

**WHEREAS, the instructions on the FY 1996 Budgets for budgets to be based on
last years budgeted amount, and that only a 4% C.O.L.A. increase
to salaries be added; and**

**WHEREAS, the Legislative Branch has prepared the FY 1996 Budget in
accordance with the FY 1996 Budget Instructions; and**

**WHEREAS, the Budget & Finance Committee has reviewed and approved the
FY 1996 Budget presented to them on August 24, 1995.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council approves the Tohono O'odham Legislative Branch FY 1996
Budget submitted by the Legislative Branch in the amount of
\$1,079,374.00.**

10 **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**
11 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




