1996; and**

**WHEREAS, the Judicial Branch of the Nation has prepared and presented a
budget that reflects the need of the Branch, said budget is attached
hereto and incorporated by reference; and**

**WHEREAS, the Budget & Finance Committee of the Legislative Council of the
Tohono O'odham Nation has reviewed this budget and recommends
its approval and adoption.**

**NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono
O'odham Nation that it approves the FY 1996 budget submitted by
the Judicial Branch.**

18 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
19 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
