

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Override Vetoed Resolution No. 95-399 (Allocation by Option #2 "Population
Distribution" and Rescinding Resolution No. 95-331))**

RESOLUTION NO. 95-413

WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 95-399; and

WHEREAS, upon presentation of Resolution No. 95-399 to the Chairman of the Tohono O'odham Nation, he did disapprove thereof and returned it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham Nation; and

WHEREAS, the Tohono O'odham Legislative Council has reviewed the Chairman's objections and after consideration; again voted to pass Resolution No. 95-399.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby override the Chairman's veto of two-thirds votes cast.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 11TH. day of SEPTEMBER, 1995 at a meeting at which a quorum was present with a vote of 941.0 FOR; 935.0 AGAINST; -0- NOT VOTING; and (08) ABSENT, failed to pass because it did not receive a (2/3) [1,251.] of the votes casts as required by Section 2 of Article V of the Consitution of the Tohono O'odham Nation.
